

NCC PORCELAIN INTENSIVE CLEANER

Exterior use.

Suitable for all types of external porcelain paving.
Effective for removing, grease, ingrained dirt, grime and tannin stains from detritus.

Important: Mask and protect painted surfaces, untreated wood and other sensitive areas. Any alkalinity/product remaining on surfaces should be completely neutralised. This may be done with a little clean water applied by sponge.

Directions for use

SHAKE WELL BEFORE USE

Always test on an inconspicuous area prior to general use.

Mild cases: Dilute 1:10 parts in warm water. Apply with a light pressure sprayer or scrubbing brush. Agitate the surface using a deck brush or scrubbing brush. Rinse by hosing off thoroughly with clean water.

Severe cases: Dilute 1:3 parts warm water. Apply liberally using a light pressure sprayer or spreading over the surface with a deck brush. Leave for 5-10 minutes and then agitate the surface using a deck brush or scrubbing brush. Rinse by hosing off thoroughly with clean water.

Extreme cases: Apply undiluted, add a little water and agitate with a deck brush or scrubbing brush. Leave for 5-10 minutes and then agitate the surface using a deck brush or scrubbing brush. Rinse by hosing off thoroughly with clean water. NB. In all cases on larger areas mechanical scrubbers can also be used..

Storage information

Store in a cool, dry, frost-free environment in closed container.
Shelf life up to 2 years.

Other

Empty containers are recyclable. Active ingredients are water soluble and inert once cured so therefore not harmful to the environment and ecologically sound.

Notes: Cleaned patios that have been previously protected should be topped up with a further protective coat of NCC Porcelain Tile Protector. This should be done after rinsing with plenty of clean water and once surfaces have had sufficient time to thoroughly dry (min. 24hrs).
